CALL TO ORDER

A regular meeting of the Graduate Student Assembly was called to order at 7:01PM on November 1, 2016 in the Nebraska Union. President Correas chaired the meeting and Executive Vice President Da Silva recorded the minutes.

APPROVAL OF THE MINUTES
